### **CHAPTER 19:09**

## COUNTING UNREMUNERATED WORK ACT

An Act to require the Central Statistical Office and other public 29 of 1996. bodies to produce and maintain statistics relative to the counting of unremunerated work and to provide a mechanism for quantifying and recording the monetary value of such work.

# [16TH OCTOBER 1996]

Commencement.

WHEREAS in 1985 the United Nations General Assembly adopted a Preamble. resolution which states that the unremunerated contributions of women to all aspects and sectors of development should be recognised, and appropriate efforts should be made to measure and reflect these contributions in national accounts and economic statistics and in the gross national product:

And whereas it is public policy to develop the contribution of women to the social, political and economic life in the country.

- 1. This Act may be cited as the Counting Unremunerated Short title. Work Act.
  - 2. The Director of the Central Statistical Office shall—
- Duties of the Director of the
- (a) conduct periodic household surveys, at least once Central every three years to assess household incomes and Office. breakdown of expenditures;
- (b) conduct surveys of unremunerated work performed in Trinidad and Tobago including—
  - (i) work performed in and around dwelling places;
  - (ii) work related to the care of children, the handicapped, the elderly and other care services;
  - (iii) agricultural work and work related to food production;

- (iv) family businesses, and
- (v) volunteer and community work in both the formal and informal sectors of society;
- (c) calculate the monetary value of such unremunerated work separately for men and women; and
- (d) utilise the quantifications in paragraphs (b) and (c) for the purpose of compiling a supplemental record to the Gross National Product.
